Sub : Process for Tracking BSNL employees GPF Cases on Separation as well as on transfer & relieving from one Circle to another – Reg.

This is with reference to the letters cited above on the captioned subject. As explicitly stated in these communications, it is mandatory for all absorbed employees' GPF data—both those who have been separated from BSNL and those who have been transferred or relieved from one circle to another—to be promptly submitted to the CCAs and updated in the ERP-SAP tracker.

However, the maintenance of record is not in order, as observed from the data available in the ERP. The Establishment Finance section is nodal section at the corporate office level, for ensuring appropriate record in the matter of GPF claims. The circle teams are advised to complete the data entry as follows:

- (i) Immediately update all pending GPF records in the ERP-SAP tracker, ensuring accuracy and completeness.
- (ii) Submit a compliance report to Establishment Finance Section, Corporate office by 10th April 2025, confirming the corrective action taken to prevent future occurrences.

Non-compliance will be viewed seriously as the matter is being closely monitored by the TOP Management. The status as on 21.03.2025 is attached for reference.
