
Sir,

Kindly refer to this office letter under reference, wherein the details regarding the vacancies that have arisen due to Superannuation/ Promotion/ Resignation/ Death etc. till the end of calendar year 2025 were sought for the preparatory work for conducting Limited Internal Competitive Examination (LICE) for the promotion to the post of Junior Hindi translator (JHT). Keeping in view the excess/surplus working strength of JHTs in few Circles, the vacancy details provided by the Circles has been considered and ensuring the equitable distribution of available vacancies among the deficit Circles (with positive vacancies), the vacancies have been distributed such that the working strength does not exceed the total sanctioned strength upon filling the posts. Upon consideration as above, it has been decided to fill up 31 vacancies of the VY 2025. Accordingly, the approved vacancy allotment for filling up of the post of JHT for LICE for the VY 2025 is enclosed as an Annexure- I.
