- iii. **Result for 2(two) vacancies are kept on hold due to pending Court case. On receipt of final outcome, the result of the same would be declared accordingly and merit position of the same shall be re-ascertained thereby.**

The result will be subject to the outcome of court cases/ direction for the matter "reservation in promotion" and on "own merit concept" pending in different courts or any other court case on the issue related to reservation and also DoP&T instructions issued from time to time and endorsed by Establishment section of BSNL.

6. Since the **Jarnail Singh** batch of cases is pending in the Supreme Court of India, any promotion order issued shall be subject to further orders that may be passed by the Supreme Court in the said batch of cases.
