Subject: Sanction of hired vehicle for the OFC route maintenance in Territorial Circles and Metro districts-regarding.

This is in continuation to above captioned subject and reference letter issued by CFM cell, BSNL CO. As per letter, total 2332 nos of Hired vehicle and 219 nos. of OLA/UBER vehicles have been sanctioned to circles for FY 2023-24. These justifications are supersession of all earlier communications in this regard, approval of the competent authorities.

For OFC maintenance 100% vehicle shall be hired and no OLA/UBER will be used and vehicle allocated for the same cannot be diverted for any other purpose.

The justification of vehicles for OFC route maintenance SLA & IN-house is as per norms i.e. 300Kms per FRT in Plain Area & 250 Km per FRT for Hilly area (in-house mtce.) and 1800Km per FRT for Plain area and 1400 Kms for Hilly area (in case of Outsourced routes).


*The requirement has been arrived at after taking into consideration existing departmental vehicles in the Territorial Circles and based on norms which are enclosed at annexure-1.

* Above mentioned budget is exclusive of budget for departmental Vehicles and the same may be requested from CBB Cell by the Circles respectively.

B. Others Important Points.

1. Every hired vehicle must be GPS fitted and journeys are tracked.
2. For OFC Route and BTS maintenance 100 % vehicles shall be hired and no OLA/UBER will be used and vehicles allocated for same cannot be diverted for any other purpose. If any vehicle is found to be diverted for any other purpose then the controlling officer will be held responsible and after 2 months payment will be linked with GPS report.
3. All hired vehicles should be procured through GEM. Regarding the minimum commitment of km per month while tendering for hired vehicles, the same may be decided by the CGM in concurrence of Circle IFA as per financial prudence and taking into consideration the requirement of a specific BA.
4. The vehicle norms have been arrived at inclusive of projects including Bharatnet and BBNL. For 4G Saturation project the expenditure is to be booked in separate GL for which norms have been communicated separately by CM vertical.
5. All other external project related vehicle like KLI and NFS should be booked separately against these project. For External project, the concerned vertical shall finalise the norms against which the expenditure is required to be booked separately. And send the requisition to CFM Cell to issue orders and budget allotment.

This issues with the approval of CMD BSNL.

Vehicles Norms:

1. **For GM and above:** - One vehicle for each individual.
2. **Local Network Maintenance:** - One Vehicle(**13K DEL Copper and 26K DEL Fibre**)
3. **Route Maintenance of OFC :-**
 - a. One Vehicle for every 300 RKMs for plain areas and 250 RKMs for hilly areas (**OFC Route maintained by BSNL**)
 - b. and one vehicle for SLA Based inspection for every 1800 RKMs for plain areas and 1400 RKMs for hilly areas (**OFC Route maintenance outsourced**)
4. **BTS Maintenance:-**
 - a. One vehicle for every 100 wireless BTS in an LSA (**BTS maintained by BSNL**)
 - b. and One Vehicle for FRT on every 500 BTS (**BTS maintenance outsourced**)
 - c. and One Vehicle for each MSC in LSA
5. **Enterprise Business :-** One Vehicle
6. **Vigilance:-** One Vehicle
7. **Civil and Electrical:-** One vehicle each for Civil and Electrical
8. **Finance wing: -**
 - a) One Vehicle each for Circle IFA and BA's IFA
 - b) One vehicle for collection in each Circle and BA
