With reference to above, for serving employee below JAG level, 40% concession with a ceiling of Rs 300/- for residential service connection, for plans above Rs 595/- is admissible. For Plans below Rs 595, two FTTH plans are available i.e. Rs.299(Urban)/249(Rural) but these plans are not eligible for concession. Similarly, Executive/Non Executive who have retired from BSNL/DOT, there is no concessional offer in FTTH connection, if plan is below Rs 595/-

There are approximately 1091 landline service connection working under "WORKING RES BSNL EMPLOYEES" & "RETIRED BSNL EMPLOYEES" category in Chhattisgarh which have only voice facility. For only voice facility in landline there is no FMC for residential service connection for BSNL employees.

As per the instructions of BSNL Corporate Office conversion of Copper to FTTH is to be done on priority. Speedy conversion is getting delayed due to the fact that residential service connections with lower plans are not consenting for conversion due to the fact that they will get FMC on conversion whereas presently they are getting the connections free of cost.

Necessary guidelines may kindly be issued in this regard.
