2. O/o CGCA, vide their letter cited at ref (a), and from time to time, has been reiterating for timely settlement of all the superannuation pension cases so as to achieve 'Zero Pendency Mission'. Despite repeated correspondence and reminders thereon, the delayed submission of superannuation pension cases of BSNL absorbees to this office by the BSNL units is continuing which is in violation of timelines prescribed under Rule 60(4) of CCS(Pension) Rules, 2021.

5. It is pertinent to mention that the superannulation pension cases are not being received by this office from the BSNL units well within stipulated time (i.e., at least 04 months prior to retirement) in accordance with the rule which is causing settlement of various shortcomings/issues with regard to service book entries/service verification/clarifications well in advance prior to retirement date. This is further causing delayed settlement of the pension cases. A significant number of pension cases are still pending with the delay from the prescribed timeline ranging between 30 to 212 days as of 30-06-2025. The list of non-received Superannuation retirement pension cases and the delay from the prescribed timeline is given at Appendix A (overleaf).

4. In view of the above, it is once again urged that the prescribed timelines for submission of pension cases under CCS(Pension) Rules, 2021 be adhered to strictly. Further, it is requested to ensure immediate submission of the pension cases duly scrutinized and completed in all respects.

5. It is also reiterated that in case of inordinate delay, responsibility should be fixed and penal interest for delay in payment may be considered for recovery from the concerned officer(s), as

Subject: Zero Pendency Mission on pension cases-reg

While reviewing the monthly reports received on the subject it has been observed that there are still cases of delayed payment of pensionary benefits to the retiring employees/pensioners. In some cases, the pension papers are not received from the concerned BSNL units for months due to one reason or another.

2. CCS (Pension) Rules, 2021 provide that where the amount of pension and gratuity cannot be determined for reasons other than the departmental or judicial proceedings, provisional pension and provisional gratuity is required to be sanctioned in accordance with Rule 62 of CCS (Pension) Rules, 2021. However, in certain pending pension cases, this has not been followed by the concerned Head of offices, which may result in claim of Interest on delayed payment of gratuity and pension in future. Similarly, attention is invited to Rule 8(4) and (5) of CCS (Pension) Rules, 2021 for authorizing provisional pension in cases where departmental or judicial proceedings may be pending. BSNL office of retiring employee must process and submit pension papers as per schedule mentioned under Chapter X of CCS (Pension) Rules, 2021.

The Competent Authority has therefore directed that a co-ordination meeting between 3. O/o CCA & BSNL at appropriate level, to be decided by Pr CCA/CCA or Jt CCA ( where HoC), be held at all field units to review the pending pension cases as well as the pension cases due in ensuing 3 months. It is requested to issue instructions to all BSNL field units for processing and forwarding the pension cases timely as per schedule and BSNL units may be directed to attend monthly meeting with concerned CCA office to sort out any issues in the submission of complete pension papers to the CCA office.
