Recruitment Rules of BSNL Management Services (Stream wise) -2023 have been notified vide this office letter of even number dated 31-12-2022. Some inadvertent typographical error in Sl. No. 1&7 of Column 5 under Schedule-I of Recruitment Rules of BSNL Management Services (Stream Wise)-2023 have been noticed. The same stands corrected and may be correctly read as under:

(a) For TELECOM OPERATIONS/FINANCE/CIVIL/ELECTRICAL STREAMS:

In the field of selection and minimum qualifying service for promotion to AGM/DE and equivalent level provided under S.No. 1, Column 5 of Schedule-I, in the last lines **....7 years of regular service as on 1<sup>st</sup> January of the vacancy year** under internal quota by promotion through selection method may be correctly read as **....7 years of regular service in the grade as on 1<sup>st</sup> January of the vacancy year** and **..5 years of regular service as on 1<sup>st</sup> January of the year to which vacancy pertains...** under internal quota through LICE may be correctly read as **....5 years of regular service in the grade as on 1<sup>st</sup> January of the year to which vacancy pertains....**

(b) For ARCH/TF/CSS/CSSS & OTHERS STREAMS

In the field of selection and minimum qualifying service for promotion to AGM and equivalent level provided under S.No. 1, Column 5 of Schedule-I, in the last lines **....7 years of regular service as on 1<sup>st</sup> January of the vacancy year** under promotion by selection may be correctly read as **....7 years of regular service in the grade as on 1<sup>st</sup> January of the vacancy year.**

(c) For FINANCE/CIVIL STREAMS:

In the field of selection and minimum qualifying service for promotion to PGM and equivalent level provided under S.No. 7, Column 5 of Schedule-I, **....03 years of regular service as on 1<sup>st</sup> January of the vacancy year** under promotion by selection may be correctly read as **.....03 years of regular service in the grade as on 1<sup>st</sup> January of the vacancy year.**
