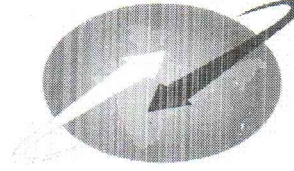

Further, it is also mentioned that there is no co-relation between seniority and rosters. No representation on this account shall be entertained.


