Sub: Tele-density and Market Share Report as on 30.06.2025

As on June-25, the number of total telephone subscribers in the country is 1218.36 million with a net increase of 11.28 million during the month. Achievement in the total telephone subscribers of BSNL's (-) 0.33 million, Jio's (+) 2.62 million, Vodafone-Idea (-) 0.27 million & Bharti's (+) 1.02 million.

The total number of wireless subscribers in the country is 1170.88 million with a net increase of 2.45 million during the month. Achievement in the total wireless subscribers of BSNL's (-) 0.31 million, Jio's (+) 2.17 million, Vodafone-Idea (-) 0.22 million & Bharti's (+) 0.97 million.

The total number of wireline subscribers in the country is 47.49 million with a net increase of 8.83 million during the month. Achievement in the total wireline subscribers of BSNL's (-) 0.02 million, Jio's (+) 0.45 million, Vodafone-Idea (-) 0.05 million & Bharti's (+) 0.05 million.

The total number of (wired) Broadband connections in the country is 44.69 million with a net increase of 0.60 million during the month of June-25. Achievement in the total (wired) Broadband subscribers of BSNL's (+) 0.03 million, Jio's 0.42 million, Bharti's 0.15 million & others (+) 0.00 million.

The total number of (wireless) Broadband connections in the country is 935.02 million with a net increase of 4.25 million during the month of June-25. Achievement in the total (wireless) Broadband subscribers of BSNL's (-) 0.66 million, Jio's (+) 2.17 million, Bharti's (+) 2.03 million, Vodafone-Idea's (+) 0.72 million.

The tele-density & market share of all telecom operators is prepared based on TRAI and BSNL MIS / NWO-CM cell report is enclosed as Annexure-1 to 6 & 8 to 10. The summary of annexures is enclosed as Annexure-A, (6 sheets)

From the two reports, it is seen that:

1.0 Total telephone Subscribers: (Annexure-4)

- i) The number of total telephone subscribers are 1218.36 million, out of which 98.01 million are provided by BSNL.
- ii) BSNL has been at 4th position with Market share of 8.04 %. BSNL market share has decreased from 8.15% to 8.04% (0.33 million) subscribers during the month of June-25.

• Wireless subscriber (Annexure-5/6)

- i) The number of total wireless subscribers are 1170.88 million, out of which 90.46 million are provided by BSNL.
- ii) BSNL has been at 4th position with Market share of 7.73 %. BSNL market share has decreased from 7.77% to 7.73% (0.31 million) subscribers during the month of June-25.

- **Wireline subscriber (Annexure-8)**

- i) The number of total wireline subscribers are 47.49 million, out of which 7.55 million are provided by BSNL.
- ii) BSNL has been at 4th position with Market share of 15.90%. BSNL market share has decreased from 19.59% to 15.90% (0.02 million) subscribers during the month of June-25.

2.0 For Broadband Services

- **Wired Broadband (Annexure-BB)**

- i) The total number of Wired Broadband subscribers are 44.69 million, out of which 4.35 million are provided by BSNL.
- ii) BSNL has been at 3rd position with Market share of 9.73 %. Its market share has decreased from 9.80% to 9.73% with addition of 0.03 million connections during the month of June-25.

- **Wireless Broadband**

- i) The total number of Wireless Broadband subscribers are 935.02 million, out of which 29.33 million are provided by BSNL.
- ii) BSNL has been at 4th position with Market share of 3.14 %. Its market share has decreased from 3.22% to 3.14% (0.66) million connections during the month of June-25.

3.0 Summary

- i) Tele-density in the country is 80.11 % with Delhi License area at top (231.06%) and UP (E) License area at lowest (55.73 %) as on 30.06.2025. The overall Broadband (wired) tele-density in the country is 2.94 % out of which BSNL has provided 0.29 %.
- ii) In respect of BSNL total telephone connections, Kerala LSA is top ranked LSA followed by Tamilnadu & UP (E), whereas among all operator's License area wise, BSNL holds 3rd rank in Kerala, Assam, HP, J&K, NE & Orissa with market share of 22.94%, 11.30%, 19.42%, 7.00%, 10.25% and 15.73% respectively.
- iii) In respect of wireless telephone connections, Kerala LSA is top ranked LSA followed by U.P (E) & Tamilnadu However, in terms of market share contribution for wireless connections among all operators within the state. BSNL holds 3rd rank in Assam, HP, J&K, NE & Orissa with market share 11.09 %, 18.75 %, 6.84 %, 10.01 % and 15.58 % respectively.

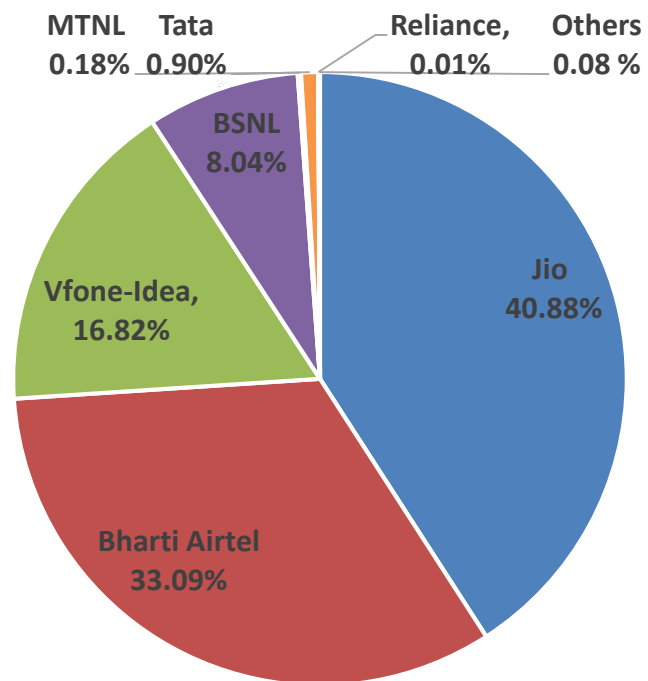

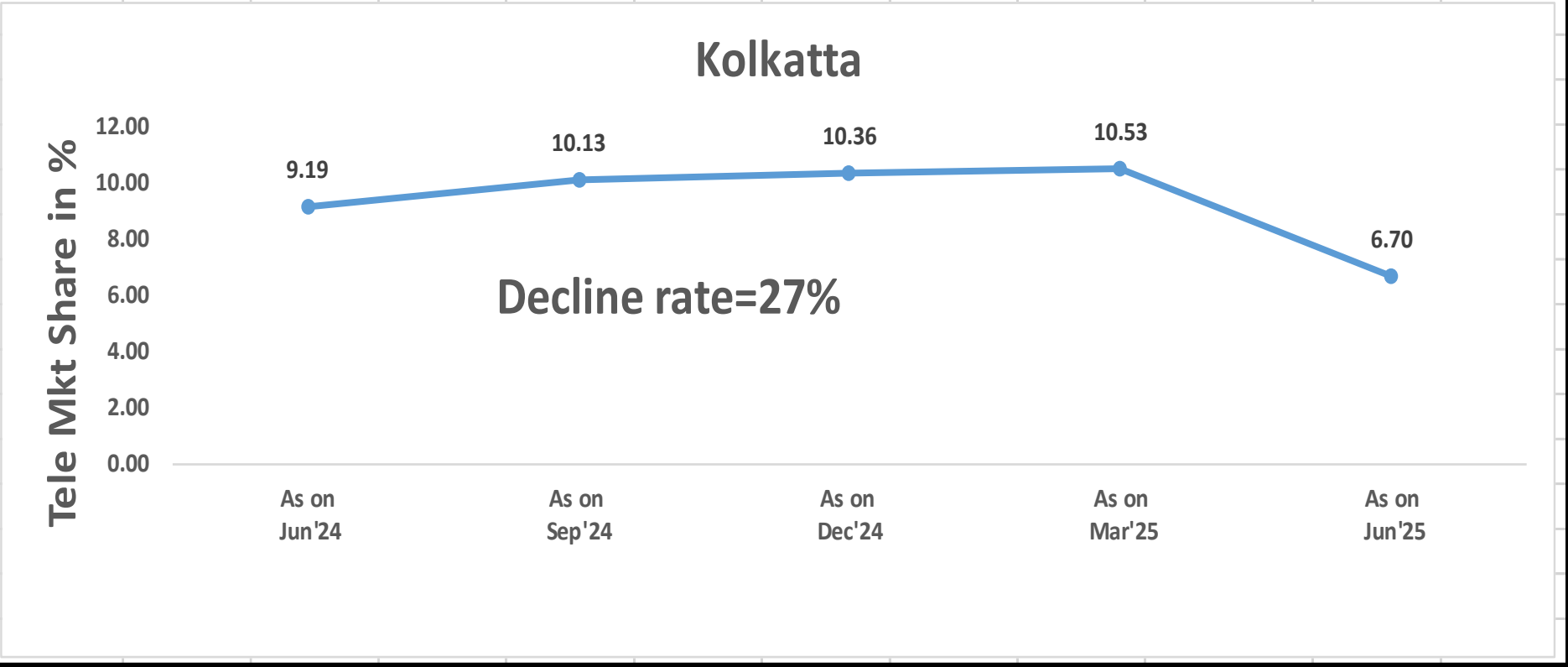
