Please refer the letter under reference 1 vide which territorial circles were requested to conduct Motivational Training by Circle Master Trainers from July 2023 onwards in a way that all the remaining employees of territorial circle and nonterritorial circle falling in the purview of that circle must be trained well before 30th November 2023.Accordingly, circles had planned and started training for their employees as per the guidelines issued by this office.

Further, as desired by BSNL Corporate Office and to facilitate circles in expediting the training, ALTTC has worked out the schedule to conduct motivational training by Circle Master Trainers vide letter under reference 2. ALTTC also conducted training of Master Trainers in addition to the previously conducted "Training of Master Trainers" for circles where sufficient number of master trainers were not available.

Expected outcome of training as per the given schedule has been assessed by this office based on the entries made in CTMS. Circles like UP(E), Haryana, Assam, Gujrat and Andhra Pradesh have done very well in conducting training. However, few circles need extra emphasis in achieving the target of completion of training of all the remaining employees by December 2023. Overall Circle wise progress of Motivational Training for the batches ending on or before 31st October is enclosed at Annexure – I.

All the circles are requested to conduct training of remaining employees falling in their purview as per the given schedule. Further, circles are requested to encourage their SPOCs and Circle Master Trainers to coordinate with the mapped training centre for any kind of guidance and support in conducting the above training.
