In continuation to this office letter dated 09.02.2023, kindly find enclosed herewith a copy of order sheet dated 16.06.2023 passed by the Hon'ble Tribunal in the above said OA for making strict compliance of the orders of the Hon'ble Tribunal. Following order has been passed by Hon'ble Tribunal:

"After pesual of the seniority list, rules of promotion and after taking into account the submissions of both counsel, we are of the opinion that promotion approved vide order dated 04.01.2023 need not be withheld from implementation particularly because majority have already joined and only 17 out of 57 remain to join. Under this factual matrix, the interim relief granted on 07.02.2023 is hereby vacated. However, promotion so effected, shall be subject to the outcome of this OA."

In this regard, approval of competent authority is hereby conveyed for the following:

1. Those executives who have been promoted from SDE(C) to EE(C) grade vide promotion order dated 04.01.2023 but could not join at their respective place of posting in wake of order of status quo on joining passed by Hon'ble Tribunal vide order dated 07.02.2023, are hereby allowed to join at their respective place of posting as per promotion order dated 04.01.2023.
2. Temporarily shifting of post of EE(C) Gwalior to AGM(L&B) O/o GM(L&B) Bhopal.
3. The following executives who have been repatriated vide this office order dated 29.03.2023 and 29.05.2023 are hereby posted as under with immediate effect:
