Subject:- Implementation of Annual Transfer and Posting of officers in various cadres of Telecom/Finance/Civil/Electrical stream due to promotion, Own request, Long stay etc. – regarding

The Officers listed in the enclosed Annexure-1, who were transferred vide order cited at Ref-1 or later but the implementation of their orders were later "Deferred" under Medical Category shall be relieved immediately as their case is either not in the list of medical condition notified by BSNL CO or not recommended by Circle. Orders in respect of officers listed in Annexure-2 are issued in partial modification to the Order under Ref-1 or later. Further, the conditions/ guidelines prescribed in the Order cited under Ref-7 are applicable to all the executives retained up to 31.03.2027 under Medical category and the executives concerned shall complete the process as per the guidelines stipulated in letter/ Order cited under Ref-1, 2 & 7, well before 31.03.2027 to become eligible for further extension, failing which, such executives shall stand relieved on the A/N of 31.03.2027 automatically.


2. Vide Order under Ref-6, Circle heads were directed to relieve all executives, who were covered under order at Ref-1 or later and not covered by any retention order of this office, or whose retention period is already over. Review of compliance status of the said order reveals, as many as 62 executives are yet to be relieved and such non-compliance by the CGMs/ unit heads concerned is being viewed seriously. It is once again directed to fully comply with the Ref-6 order immediately without any further delay and report compliance. Failure to do so would attract action as deemed fit against the officers responsible for the same.

3. It has been further decided that:

- The executives who are on deputation in other departments, shall join at the posted Circle directly on completion of the deputation tenure.
- The joining status of the executives relieved from their present Circle and joined at their transferred Circle shall be updated properly in SAP/ERP.



- c). Executives relieved but not joined at their transferred Circles are directed to join their transferred Circle immediately, failing which Disciplinary Proceeding will be initiated against them.
- d). The executives who have been retained on immunity ground under REA rules shall stand relieved on the afternoon of the last day of the retention period automatically.
- e). The Court cases due to which orders in respect of certain executives are pending for implementation shall be pursued vigorously for getting the stay vacated/ final disposal in a timely manner. The details of such cases must be intimated to this office immediately.
- f). The executives who were transferred vide order cited at Ref-1 or later but retained as "Deferred" under medical category, excluding those under Annexure – 1 & 2, shall complete the process as per the guidelines stipulated in letter/ Order cited under Ref-1, 2 & 7, by 15.07.2026 and the report forwarded to BSNL CO by 20.07.2026, failing which the concerned executives shall stand relieved on the A/N of 31.07.2026 automatically.

Accordingly, all Circle Heads/ Unit Heads are requested to ensure strict compliance of the above said decision and non-compliance if any will be viewed seriously.

This issues with the approval of the competent authority.
