

Sub: Conduction of All India Conference in April/May 2025 and extension of CHQ Body for period of three month or date of all India Conference which is earlier.

Ref: Letter No. SNEA/CHQ/CWC Corr/2022-25/Online/01 Dated 9/12/2024.

In continuation of discussions held in online CWC Meeting held on 11th & 12th January 2025, it was unanimously resolved to hold the All India Conference in April/May 2025 at one of the place as proposed by CS SNEA Kerala at Cochin, CS SNEA MP at Bhopal and CS SNEA MH at Nagpur and the final decision on Venue and place of All India Conference will be taken by SNEA CHQ.

It was also discussed that the tenure of present CHQ Body is up to 14/04/2025 and in case the date of All India Conference goes beyond this date the tenure of the present Body needs to be extended.

As such, as per the provisions under clause No 4 (a) (ii) of SNEA constitution, it was finally resolved by CWC Meeting that the tenure of Present CHQ Body will be extended till date of the All India Conference scheduled in April/May 2025 or three months from 14/04/2025, whichever is earlier.
