## Circular for CWC Meeting

### Dear CSs, CHQ OBs and CWC Members,

As notified vide letter No. SNEA/CHQ/CWC Corr/2022-2025 Dated Sunday, 2<sup>nd</sup> April 2023, the Central Working Committee (CWC) Meeting of Sanchar Nigam Executives' Association, Central Head Quarters will be held for three days from 03/05/2023 to 05/05/2023 at The Central Court Hotel, Beside Lakdikapul Metro station, Lakdikapul, Hyderabad, Telangana State PIN 500004. The detail schedule of the meeting will be shared in the CWC Meeting.

Tentative important activities of CWC are as follows.

- This CWC meeting will start from 0900 Hrs of 03/05/2023 and will conclude by 1900 hrs on 05/05/2023.
- The CHQ OB Meeting will be held prior to CWC Meeting at the same Venue at 1700 Hrs on 02/05/2023.
- The Open Session will be held at The Institution of Engineers, Visvesvaraya Bhavan, Beside Khairtabad Metro Station, Khairtabad, Hyderabad, Telangana State 500004 at 1400 Hrs on 04/05/2023.
- The proceedings of CWC Meeting will finally conclude at 1900 Hrs with felicitation of Shri. Padmanabha Rao, Ex AGS HQ SNEA CHQ at 1600 Hrs on 05/05/2023.

Our active and brave team of SNEA Telangana led by Shri. Kulla Suresh CS SNEA Telangana, Shri. Dargaiah CP SNEA TG Circle under valuable guidance of Shri. Samala Srinivas, AGS SNEA CHQ is on the job for comfortable arrangements of this CWC Meeting.

Hyderabad is a well-known Historical and ancient City, connected by Bus, Rail. Air from all the corners of India. The venue and accommodations of this meeting are in the same Hotel and only an open session will be held at the "Institution of Engineers" auditorium, Visvesvaraya Bhavan, Khairtabad, which is just three Kms away from the Hotel accommodations. The accommodation is just near the Lakadikapul Metro station and the auditorium is just near Khairtabad Metro Station.

SNEA Telangana has made arrangements to receive CHQ OBs, CS and CWC Members attending Circle Working Committee Meeting. The venue is at 2.6 Kms distance from Hyderabad Deccan/ Nampalli Railway Stations. 6.2 Kms from Secunderabad Railways Station, at 5.2 Kms from Kacheguda Railway Station and at about 35 Kms from Hyderabad Airport. The Host Circle has made arrangements to receive delegates attending this CWC Meeting at all these stations depending on the arrival of delegates. All CS, CWC Members and CHQ OBs are requested to share their journey details to Shri. Tata Babu CHQ Treasurer, who in turn will update team SNEA Telangana for accommodations arrangements and for receiving them at railways stations.

All CS, CHQ OBs and CWC Members should come fully prepared for attending this CWC Meeting and specifically the Circle Secretaries are requested:

- 1. To hold CEC Meetings of Circle by online/offline mode as feasible before CWC Meeting, to discuss and decide the issues to be taken from Circle at this CWC Meeting
- 2. To email resolution pertaining to the Organizational/HR issues & agenda points for discussions in CWC Meeting duly approved in the CEC meetings to Shri. Pavitra Singh AGS HQ about Development Issues & agenda points for consideration and inclusion in the Schedule/Agenda of CWC Meeting.

# 3. It is compulsory to each and every Circle Secretary, CHQ Office Bearers and CWC Member to attend the CWC Meeting

- 4. But till any of the Circle Secretary is unable to attend the CWC meeting due to any unavoidable reason, he should nominate any other SNEA Circle OBs, preferably CP or one of the ACS in his/her place with prior intimation to Shri. Manish Samadhiya President CHQ.
- 5. During the CWC proceedings for three days, CHQ OB, CS or CWC Member should not leave venue of the meeting for any reason and will have to participate in the meeting with full devotion & dedication.
- 6. We have already taken up matter with BSNL Management for the special CL for eligible OBs, and details will be shared shortly. Others who are not eligible for Special CL are requested to attend this CWC Meeting with personal CL/EL as the case may be.

- 7. To plan in advance by booking railway tickets along with CWC Members and make it convenient to attend this first CWC Meeting and make it a grand success by their active participation and involvement.
- 8. To intimate arrival/departure details to Shri. Tata Babu CHQ Treasurer by email on tatababukaranam@gmail.com latest by 28/04/2023.
- 9. The stay and accommodation arrangements will be available from the morning Hours of 03/05/2023 to Morning Hours of 05/05/2023 and food arrangements will be available from breakfast on 02/05/2023 to dinner on 05/05/2023. The locker facility will be provided from morning of 05/05/2023 as all rooms will be vacated by 1000 hrs on 05/05/2023.
- 10. If due to any reason, may be due non-availability of journey tickets on that particular date or any other personal reason, or for site seeing in Hyderabad, any office bearer, needs the accommodation arrangements before 03/05/2023 and needs stay arrangements from 05/05/2023, may share details with Shri. Tata Babu CHQ Treasurer, who in consultation with Shri. Kulla Suresh, CS SNEA Telangana will make stay arrangement available on payment basis by leaders either in IQs or Hotels and individuals should intimate details to CHQ Treasurer latest by 28/04/2023.
- 11. Host Circle has made arrangements of accommodation for three persons in one room and efforts will be made to keep delegates arriving from a particular Circle together. The individual leaders who are visiting Hyderabad along with family members, details may be shared with CHQ Treasurer, and separate arrangements will be made for such leaders and their family members on payment basis.
- 12. Please note that Hyderabad is costly city & accommodation will be made available to the delegates who will intimate details in given time i.e. latest by 28/04/2023 and accommodation will **not be provided** by host branch for any delegate /observer attending CWC Meeting without such advance intimation and whole responsibility of such delegates lies with CS concerned to make their arrangement as he thinks fit.
- 13. All are requested to plan their journey accordingly by railway, bus or by their own vehicle and it is up to Office Bearers to decide about the class or mode of Journey by which they travel, but in case of reimbursement from SNEA CHQ, same will be made as per the Three Tier AC Coach railway fare for same route regardless of the expenditure made by individual on such travelling.
- 14. We are putting these conditions **under extreme compulsions** as arrangements at Hyderabad are very costly and after all we have to **save money of our beloved association** and hence all are requested to co-operate for economical and at the same time for excellent arrangements of this CWC Meeting.
- 15. All CS are further requested to bring along with them the information in hard as well as soft copy as per the format which is being shared by Shri. Manish Samadhiya, President SNEA CHQ.

- 16. All the Joint Secretaries of SNEA CHQ are specially requested to be in touch with all the Circle Secretaries in their area and see that all CS and CWC Members are attending CWC Meeting in person or if due to any genuine issue, CS is unable to attend the meeting he deputes one of prominent COBs in his place along with all relevant information, CEC resolutions and issues with prior intimation to Shri. Manish Samadhiya President SNEA CHQ.
- 17. The constitution of SNEA doesn't permit any observer for CWC Meeting as it increases expenditure on arrangements in the most costly city like Hyderabad, the expenses are very high and it is most difficult to get suitable and economical accommodation and hence no observers will be normally allowed except written & prior permission from Shri. Manish Samadhiya, President SNEA CHQ and all such permitted observers will have to pay Rs. 2000 each as observer fee.
- 18. It may be please noted that observers can attend meeting with such permission but they are not allowed to take part in discussions or submit their views directly in CWC Meeting and same can be submitted through CS concerned or CWC Members from their Circles. In case observer pay is not deposited, same will be adjusted from the Circle Quota of the concerned Circle.
- 19. We welcome suggestions and guidance from all of you for the successful conduction of CWC Meeting and all are requested to send it well within time to AGS HQ.

All are requested to take note of all above points and make it convenient to attend the CWC Meeting well in time as specified above, with full preparations and make it a grand success.
