Subject: Confirmation in service after completion of probation period in respect of Management Trainees (Telecom Operations) recruited under MTRR-2013 – Furnishing of requisite certificate and vigilance profile – reg.

It is intimated that vide Letter No. E329231 BSNLCO-11/13(11)/1/2022-RECTT-CO-Part(2) dated 20.04.2023, Recruitment Branch, BSNL Corporate Office declared the result of 150 successful internal candidates selected for appointment as Management Trainees (Telecom Operations) under the provisions of MTRR-2013.

2. As per the terms and conditions of the recruitment notification and the relevant provisions governing the post, the selected candidates were required to undergo 52 weeks of training followed by appointment as Manager (MT). Further, the Management Trainees were to remain on probation for a period of two years running concurrently with the training schedule. Accordingly, vide letter no. BSNCO-PETS/12(11)/1/2023-Pers1 dtd 26.05.2023, the candidates selected for MT were offered to undergo 52 weeks training. Further, vide letter no. BSNLCO-PETS/12(11)/1/2023-Pers1-Part(1) dtd 01.03.2024 the said executives were allotted the circles for on job training.
3. The Management Trainees concerned have since completed the prescribed training and probation period. Accordingly, the matter regarding their confirmation in service is under consideration at BSNL Corporate Office. In this regard, concerned Circles/Units are requested to furnish the status in respect of each eligible Manager (MT) under their administrative control, a certificate with respect to successful completion of the training as per the enclosed Annexure-I.
4. The Circles/Units are also requested to furnish **revised Part-I of the 13-Point Vigilance Profile** (copy enclosed) in respect of each executive along with the above certificate.
5. The requisite certificate and vigilance profile may be forwarded to this office at the earliest to enable timely processing of the cases for confirmation in service.
