**1. LICE Telecom Technician (TT) VY 2020 & 2021 exam.**

As regards, queries from concerned circles regarding non availability of details of TSM candidates in ERP for e-verification is concerned, it is requested to carry out the verification of such candidates manually considering all elements of notified Recruitment Rules. A copy of verified such TSM employees may please be forwarded to this office through mail on bsnlrectt@bsnl.co.in latest by 29.07.2023.

**2. For LICEs JTO(T) VY 2022, LICE JE(T) VY 2021 & LICE TT VY 2020 & 2021.**

The clarity about Parent circle and Parent SSA is of utmost importance for LICEs pertaining to Group 'C' & 'D' cadres. It is observed that in many cases the fields of Parent circle and Parent SSA are blank. Therefore, all circles are requested to check the same and fill the blank fields of Parent circle and Parent SSA after verifying it from service book invariably.

**3. Admit card and preparation of results for LICEs to be held on 27.08.2023.**

After going through the verified details, admit card shall be generated for all eligible candidates. However, no admit card shall be generated for all those candidates whose details are not updated in SAP mentioned vide point no 2 above. It is also inform that the further process w.r.t. the exam shall be



initiated only when the necessary fields are duly found filled in SAP. The circles shall be held responsible for any shortcomings on this account.
