Also, the next time bound pay scale upgradation under EPP of the employee (after the date of said promotion order) shall be postponed for a period of two year from the due date.

4. Hence, regular promotion being refused by the executives and refusal being accepted by the appointing authority, on the eventual promotion to the higher grade, the executives will lose seniority vis-à-vis their juniors promoted to the higher grade earlier.
