The above mentioned executives will not be considered for any promotion (either regular or adhoc or even look after arrangement) for a period of one year or till the preparation of next panel, whichever is later, from the date of refusal by the executives. Also, the next time bound pay scale upgradation under EPP of the employee (after the date of said promotion order) shall be postponed for a period of two year from the due date.

4. Hence, regular promotion being refused by the executives and refusal being accepted by the appointing authority, on the eventual promotion to the higher grade, the executives will lose seniority vis-à-vis their juniors promoted to the higher grade earlier.
