- 4. Similarly, in respect of executives of final SDE(T) seniority list nos. 12 & 13, circles are requested to upload missing offline APARs data in ERP for the period from 2015-16 to 2016-17 & subsequent period upto 2020-21, if any executives remained on deputation. Further, APARs of any executive pending in ERP should also be completed as stipulated above.
