Subject: Promotion of executives of Civil Stream to the grade of SDE(Civil) on regular basis in E2 IDA Pay Scale of Rs. 20600-46500/-.

Approval of the competent authority is hereby conveyed for promotion of the executives of Civil Stream as indicated in the enclosed **Annexure I & II** to the grade of SDE(Civil) on regular basis in E2 IDA Pay Scale of Rs. 20600-46500/-, in accordance with the provisions of Recruitment Rules of SDE(Civil)-2002 and 2023 respectively, with effect from the date of assumption of charge of the promoted post.

2. The said promotion order is being issued after obtaining the vigilance clearance. However, in case, it comes to the notice of the concerned controlling authority that any disciplinary case is pending or any penalty is in operation or any of the circumstances enumerated in DoPT OM No. 22011/4/91-Estt. (A) dated 14.09.1992 at the time of promotion against the officer, his/her promotion order shall not be given effect and information in this regard may be brought to the notice of this office immediately along with the details of prosecution/suspension/disciplinary case/under currency of penalty, if any as the case may be.
3. All the executives on their promotion are posted in the circle as indicated in the annexure. However, management reserves the right to post any of them as per administrative requirement.
4. The executives shall join in the promoted post at the place of posting within 40 days from the date of issuance of this order.
5. All CGMs shall ensure that the posting orders in respect of executives are issued immediately and not later than 7 days from the date of this Order, to enable them to join their promotional assignment, within the prescribed time limit (including the joining time) from issue of this order.
6. All CGMs shall ensure to relieve the executives who have been ordered for transfer to other circles immediately and not later than 7 days from the date of this Order. In case

the executives concerned fails to join the promotional assignments within the prescribed period, he/she should not be allowed to join the post thereafter. In such a situation, the promotion order shall become inoperative and such cases shall be reported to this office. Further, no request for modification of posting order shall be entertained.

7. CGMs concerned are further advised that the pendency of request of the executives for modification of the posting order should not be taken as ground for holding up the relieving or implementation of the promotion order.

8. The leave, if any requested by the executives, who has been posted on promotion, should not be allowed. If any executive desires leave, he/she can apply for leave to new place of posting under whom he/she has been posted only after joining the new assignment. The new controlling executives will sanction leave, if it is considered justified as per norms.

9. Any discrepancy in name of the executive, gender, present circle, DOB, HRMS Number etc., in the Annexure may be intimated to this office immediately for issuing necessary correction. However, they may be allowed to join the promotion post.

10. The pay fixation on promotion be done as per prescribed rules amended from time to time.

11. In terms of DoP&T guidelines vide their OM dated 12.04.2022 in the matter of reservation in promotion, since the Jarnail Singh batch of cases is pending in the Hon'ble Supreme Court, the promotion shall be subject to further orders that may be passed by Hon'ble Supreme Court in the said batch of cases or any order(s) passed by any Hon'ble Court(s) in related matter.

12. The proposed promotions as above shall be on provisional basis subject to pending SLP(s) and subject to various litigation/court cases pending in different courts.

13. The particulars of executives shall be updated in the ERP as soon as they join on promotion.

14. Charge report may be furnished to all concerned and necessary entries be made in ERP/SAP/Service book accordingly.


