Information in this regard may be brought to the notice of this office forthwith.

3. The above mentioned executive(s) shall join in the promoted post at the place of posting within 40 days from the date of issuance of this order positively failing which the promotion order shall become inoperative and thereafter, such executive(s) shall not be allowed to join the promoted post. The concerned controlling authorities may kindly ensure that the promoted executive(s) is relieved in time so as to enable him to join the new assignment within prescribed time limit. Further, no request for modification of posting, etc. shall be entertained.

4. No leave shall ordinarily be granted to the executive(s) until he/she joins the promoted post.

5. The pay of the executive(s) promoted shall be fixed in accordance with Clause 13 of BSNL MSRRs-Civil-2023.


