**Subject:- Provisional SDE(T) Seniority List Nos 10, 11, 12 and 13 - Circulation thereof.**

This has reference to this office letter no. 56-09/2014-Pers(DPC) dated 13.05.2016 vide which two lists comprising updated particulars of SDEs(T) promoted under Seniority Quota (SQ) against vacancy years 2006-07 to 2008-09 and Competitive Quota (CQ) against vacancy years 2006-07 to 2009-10 were circulated for inviting objections/errors/omissions.

The provisional seniority list No 9 of SDEs(T) was published on 10.08.2020 for inviting objections/errors/omissions etc. Pursuant to this, large numbers of objections/errors/omissions were also received from the SDEs(T) promoted under SQ for vacancy years from 2007-08 to 2008-09 and CQ for vacancy years from 2006-07 to 2009-10.

Some SDEs(T) have filed OA No 310/00454/2020 in Hon'ble CAT, Chennai regarding wrong fixation of seniority in provisional seniority list No. 9 circulated vide letter No. BSNLCO-PERS/13(21)/1/2020-PERS1 dated 10.08.2020. A speaking order as per directions of Hon'ble CAT Chennai dated 28.01.2021 in the said OA has been issued vide this office letter No BSNLCO-PERS/13(21)/1/2020-PERS1 dated 09.07.2021. Further, another speaking order has been issued on 07.10.2021 in compliance of Hon'ble CAT Ernakulam Bench order dated 16.07.2021 in OA 180/295/2021 (T. T Mary Sophia & Ors Vs BSNL).

The objections/errors/omissions received in reference to letter dated 13.05.2016 and 10.08.2020 after verification of service records from circles have been considered and incorporated in provisional SDEs(T) seniority list Nos 10, 11, 12 and 13 as detailed below for inviting objections/errors/omissions etc.



As per Hon'ble High Court Bombay order dated 21.06.2011 upheld by Hon'ble Supreme Court in SLP (C) No(s) 35756/2012 (**BSNL & Ors. Vs. S. Sadasivan & Ors.**) order dated 12.08.2014, the date of promotion is being taken as date of joining. If any left out (due to un-assessed/VC pending/exoneration etc.) officer is promoted after date of issue of main promotion order and his/her name was there in the select panel, the same shall be included as per his/her position in original select panel. Similarly, if any CQ candidate left out in main promotion order of LDCE due to VC pending/exoneration etc., his/her name shall be placed as per their merit in the LDCE examination.

All objections/errors/omissions etc. received on the aforesaid provisional seniority lists may be sent by the respective circles after verifying the service records along with necessary documentary evidence in support of objections/errors/omissions etc. by 30<sup>th</sup> November, 2021 on the email id agmdpc.senlist@gmail.com. Objections /errors/omissions etc. received after 30<sup>th</sup> November, 2021 shall not be entertained/considered.
