2. BSNLCO Letter No. E329231 BSNLCO-11/13(11)/1/2022-RECTT-CO-Part(2) Dated 20.04.2023 declaring the Final Result of BSNL MT(Internal) 2019.

Pursuant to the Final Result of BSNL Management Trainee (Internal) 2019 declared vide letter no. E329231 BSNLCO-11/13(11)/1/2022-RECTT-CO-Part(2) Dated 20.04.2023 of BSNLCO (copy enclosed) and as per Letter No. BSNLCO-11/13(11)/1/2022- RECTT-CO-Part(2) Dated 23.05.2023 (copy enclosed) the candidates as listed in Annexure-I selected for appointment as Management Trainee by BSNL are hereby offered to be designated as Management Trainee (Telecom Operation) and to undergo 52 weeks training starting with Orientation Program of two weeks w.e.f. 5th June 2023 as per Annexure-I (75 candidates each at ALTTC Ghaziabad and BRBRAITT Jabalpur as mentioned in Annexure-I), as per the terms and conditions mentioned herein below. CGM ALTTC shall then provide further details of training schedule for remaining part of the training.

Further, in MA No.1546/2023 in OA No. 1526/2021 titled Narinder Kumar Vs BSNL, the Hon'ble CAT Principal Bench, New Delhi, has passed the interim order dated 10.05.2023 as follows:

" 6. We hereby modify our order to the extent that let these management trainees selected in pursuance to the 150 vacancies be allowed to undergo training. But on completion of their training only 142 candidates would be allowed to join and rest 8 vacancies shall be kept for the present applicants."

Management shall take a decision in this regard as per directions of the Hon'ble Court.

3. **TRAINING:**

- a) Selected candidates as per Annexure-I are requested to report to the training centres as per the schedule mentioned in Annexure-I. **In the event candidate fails to report to ALTTC Ghaziabad/BRBRAITT Jabalpur**, as the case may be, on the schedule date, his/her candidature is liable to be cancelled.
- b) At the time of joining training, the candidates are required to bring/ produce the following documents/bonds:
 - i) Bond in the enclosed pro-forma indicating willingness of the candidate to serve BSNL continuously for a period of at least 05 years from the date of joining the 52 weeks training program.

In the event of non-submission of any of the documents/bond etc. stated herein above, this offer would stand withdrawn and cancelled-
- c) The candidates will have to successfully complete the prescribed training, to the satisfaction of the Company.
- d) The Seniority among the internal candidates will be fixed on the basis of marks obtained in the selection process through the three stages.
- e) If a candidate fails to successfully complete the training including the examinations during training, then his/her probation-cum-training shall be extended by 6 months, followed by Examination. He/she will be placed below in seniority than the officers who have already cleared the examination. On failure of successful completion of training including examinations during training even in extended period, his/her selection as Management Trainee shall be treated as cancelled and official reverted to his/her earlier grade.
- (f) On successful completion of 52 weeks training the candidate shall be appointed as Manager (MT). Further he/she will be promoted as Assistant General Manager on working as Manager(MT) for two years subject to being adjudged fit for promotion. Candidate's further career progression, including inter-se-seniority, for promotion to higher grades, shall be regulated by BSNL MSRRs-Telecom-2023 with subsequent modifications, if any.

- g) As the training programme is very comprehensive, long leave will not normally be granted during the training period, except in most compelling circumstances.
- h) It may be noted that only single hostel accommodation is available at the Training Centres. Therefore, the candidates are **barred from** bringing their families with them.

4. PROBATION/CONFIRMATION

- a. The candidates will be on probation for a period of **Two Years** running concurrently with training schedule which may be extended at the discretion of the management, if considered necessary. During the probation period, this offer of being designated as Management Trainee is liable to be withdrawn/cancelled at any time and without assigning any reason thereof and subsequently the candidate will be liable to be reverted to his/her earlier grade. On satisfactory completion of the probation period, which shall not be deemed to have been completed unless the candidate is informed of it in writing, his/her services will be confirmed in the grade in which he/she is working. However, his/her services are liable to be terminated at any time without assigning any reason, whatsoever, by giving one month notice or payment of salary in lieu thereof, on either side, provided that in case the candidate submits resignation from the service before completion of 05 years of service in BSNL counted from the joining of 52 weeks training, then he/she will also be liable to pay the Company the amount specified in the Bond Agreement.
- b. Notwithstanding anything contained herein, in case the candidate serves the notice to the Company, the appointing authority, however, reserves the right of relieving him/her before the expiry of stipulated notice period.
- c. The company reserves the right not to accept the resignation of executives if the circumstances so warrant i.e. if the disciplinary proceedings are pending or a decision has been taken by the competent authority to issue the charge sheet etc.

5. GENERAL

- a) This offer is provisional and subject to the caste/tribe category Certificates being verified through proper channels and if the verifications reveals that the certificates submitted by the candidate in support of his/her claim of belonging to SC/ST category, as the case may be, is false, the services of such candidates will be terminated forthwith without any prior notice and without assigning any further reason and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.







under the Companies Act, 1956 having its Registered Office at Bharat Sanchar Bhawan, Harish Chandra
Mathur Lane, Janpath, New Delhi-110001 (hereinafter called BSNL which expression shall unless
excluded or repugnant to this context be deemed to include its successors/assignees, executors, legal
heirs, administrators) of the THIRD PART acting through Chairman and Managing Director, BSNL Sh.
Nereus Barwa, AGM(Pers.I) Its authorized official.

WHEREAS the Probationer has been selected by the BSNL for training in the cadre of Management

may be decided by BSNL.


Now these presents witness and it is hereby mutually agreed and declared by and between parties
hereto as follows:

1. BSNL shall provide training, the nature and duration of which shall be determined by the BSNL whose
decision in this behalf shall be final and binding.

Provided that the BSNL may at any stage without assigning any reason discontinue his training, if in its
opinion (which shall be final and binding), the Probationer appears to be unlikely to be an efficient
Management Trainee and /or Manager (MT).

2. The said Probationer shall:

- (A) Undergo the course of training at any BSNL Training Centre and other units, selected from time
to time by BSNL.
- (B) Undergo such training at the said places with due diligence and comply with the instructions of
all authorized officers in regard to training and discipline at the said places.

3. THAT the Probationer has agreed with the company that he/she shall serve BSNL in such department or departments at such place or places in India in such capacity in connection with BSNL's business as BSNL may require from time to time, for at least five years counted from joining of 52 weeks training program, on terms and conditions contained hereinafter and in accordance with the Rules and Regulations of BSNL as applicable from time to time to such probationers.


4. THAT the BSNL has called upon the probationer to furnish a Bond to the extent of Rs. 5,00,000/- (Rupees Five lakh only) for indemnifying the Company against all losses or damages which the BSNL may suffer by reason of the breach of the terms of this agreement by the Probationer.

5. THAT the Surety, at the request of the probationer, has agreed to give a Bond for the said sum of Rs. 5,00,000/- (Rupees Five lakh only) in the manner hereinafter appearing.

6. THAT the Probationer and Surety have agreed that in the circumstances if the probationer commits breach of any conditions of this Agreement or, in case the training of the said probationer is discontinued under the provisions to clause (1) above and the BSNL is satisfied that the failure of the probationer to reach the necessary standard is due to his/her work (the decision of the BSNL in this behalf being final), or in case of continued adverse reports regarding his/her conduct or his/her political activities directed against the Government of his/her Country/BSNL, or if the probationer voluntarily quits for reasons not beyond his/her control any time during the course of training, or on completion thereof does not serve the BSNL for a period up to 5 years counted from joining the 52 weeks training or during such period of service does not carry out his/her duties with diligence. BSNL shall have full powers to forfeit the amount of security deposit without any notice to the probationer and surety. 
