Sir,

BSNLCO is continuously requesting the Circles for updating the data in SAP for preparation of e-roster in SDE[T] cadre vide this office above mentioned letters.

On receipt of information regarding missing names of SDE[T] executives in the e-roster data , ERP unit of BSNLCO has now updated the entries of SDE[T] and observed that there are more no. of SDE's i.r.o whom the data correction/updation is pending vis-a vis to what informed earlier.

The fresh circle-wise details of executives as per their Pernr number in respect of whom the data updation are still pending have been extracted from SAP-ERP on 03.08.2023 and is enclosed herewith (Annexure-I).

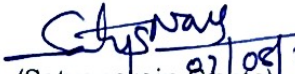
1. In this regard Circle Heads are again requested to direct the concerned staff to go through the enclosed list and complete the pending data updation. Thereafter, they can generate report using T-code Zhr\_roster\_data\_rpt to see the status of data updation of all the SDEs working in their jurisdiction. From the enclosed list, it can be seen that the start date in all the info-types are not same and so the mismatched is indicated against these Pernr nos. It is reiterated that the start date (i.e. entry date in SDE(T) cadre) shall be same in all the Info type i.e. 9007, 9016 & 9019. If start data is not the same, then error may come in the report and roster will not be generated. The joining on transfer to other circle is nowhere linked with the start date in the cadre. So circle should ensure that once the correct start date of SDE-T cadre entered in the SAP, it should not be changed unless some specific order from BSNL Corporate Office for its change. The recruitment mode (01 for SQ and 02 for CQ/LDCE) falling under Info type 9019 should also be filled up properly. These activities should be positively be completed by 18.08.2023.
- 2) In addition to SDE-T cadre, updation of data of AGM-T cadre (enclosed herewith as Annexure-II) in above mentioned three info-types SAP-ERP should also be accomplished by 31.08.2023.
